Sallie Goodwin: All that piece parcel and tract of land lying situate and being in Saluda Township State and County aforesaid, on North fork of Saluda River adjoining lands of the Estate of W. C. Goodwin and Harry Clelands Estate and others and having the following metes and bounds in accordance with survey dated January 1913 made by R. E. Dalton Esq. Beginning at a stone on the north fork of Saluda River at the mouth of the old run of a branch and on the line of W. C.
