KNOW ALL MEN BY THESE PRESENTS, That we, J. P. Poole & H. B. Poole, of the County of Greenville,

in the State aforesaid, in consideration of the sum of Ten Dollars and other valuable considerations, to us in hand paid at and before the sealing of these presents by John B. Marshall

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

John B. Marshall, All that certain piece, parcel or tract of land, situate in the State of South Carolina, County of Greenville, and having the following metes and bounds, to-wit: Beginning at corner of Parker Land Co's property and property of Mr. Roe, center of Buncombe Road; thence along the line of Roe and Parker Land Co., S. 67.35 E. 1893 feet to an iron pin, corner of Parker Land Co., Roe and H.B. Tindel; thence along the line of Tindel and Parker Land Co., N. 18.08 E. 780 feet to an iron pin, corner of Parker Land Co., and Tindel; thence N. 64.42 W. 60.7 feet to iron pin, corner of Parker Land Co., and Tindel; thence N. 76.40 W. 1957 feet to the center of Buncombe Road; thence with Buncombe Road S. 3.31 E. 273.4 feet to bend in road; thence with road S. 12.44 W. 214.4 feet to the beginning corner, being tract No. 50 of Parker Land Co., Plat No. 2, and containing 28.69 acres, more or less.
