KNOW ALL MEN BY THESE PRESENTS, That *A. P. Du Bose, of the City of Greenville*

in the State aforesaid,  
in consideration of the sum of  
*Fourteen Hundred and 25/100 (\$14.00)* DOLLARS,  
to *me* in hand paid  
at and before the sealing of these presents by *J. W. Quinn*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*J. W. Quinn, his heirs and assigns forever, all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, on Hooper's Creek and having the following meter and bounds to-wit: beginning on the south side of Hooper's Creek and running thence S. 20 E. 9.30 to a persimmon tree 37 on or near the road; thence S. 73 1/2 E. 6.25 to a rock 37 on or near the road; thence S. 7 3/4 E. 12.50 to a Sourswood 37; thence N. 84 1/2 E. 21.65 to a Sourswood 37; thence N. 44 E. 1.75 to an ash; thence N. 23 1/2 W. 16.66 to a stake 37 on branch; thence N. 80 W. 1.87 along the branch to a dogwood 37; thence along the said branch N. 64 1/2 W. 7.90; thence along the said branch N. 48 W. 2.75 to a rock 37 on Hooper's Creek thence down the creek S. 30 3/4 W. 4.00 to a rock 37 at the beginning corner, containing forty and four-tenths (40.4) acres, more or less, less one-half (1/2) acre conveyed away and being known as the "Home Place" or Tract No. 1 of the Prop.
