KNOW ALL MEN BY THESE PRESENTS, That We, J. T. E. Stokes, J. V. Hawkins, L. C. Stokes, Pearl Stokes, Meta Jenkins, and B. M. Stokes, heirs at law of Amanda J. Stokes of Greenville County in the State aforesaid,

in consideration of the sum of Six Hundred DOLLARS,

to us in hand paid at and before the sealing of these presents by J. H. Stokes of the State and County aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J. H. Stokes, all of that piece, parcel and lot of land, situated in the State and County aforesaid, in Austin Township, near Simpsonville, being a part of the land of Amanda J. Stokes, (deceased) adjoining lands of M. Pollard, H. League, L. Crisp and others, and having the following metes and bounds: beginning at stone near his house, and thence N. 54 1/2 W. 77.95 to stone, thence S. 28 1/2 W. 27.53 to stone, thence S. 62 1/2 E. 7.75 to large Poplar, thence N. 28 1/2 E. 26.60 to the beginning containing twenty-one and one-half acres more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said J. H. Stokes and his heirs and assigns, forever.

AND We ourselves and our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said J. H. Stokes and his heirs and assigns, against our and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
