at and before the sealing of these presents by Agnes B. Bursage of Greenville
S.C.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Agnes B. Bursage, her heirs and assigns;
All my undivided one half interest, share and title in and to all that piece, parcel of lot of land with the buildings thereon, situate on the north side of Hampton Ave. in the City and County of Greenville in the State aforesaid, having the following metes and bounds, as will more fully appear by reference to a plat recorded in Plat Book "A" page 187 R. M. C. Office for said County of Greenville to wit: Beginning at an oak post on the north side of Hampton Ave. 164 feet from Academy St. thence with Hampton Ave. N. 48 deg. 50" E. forty ft. to iron pin, (corner Reynolds lot) thence with line of last mentioned lot N. 32 deg. 30" E. one hundred ft. six inches to oak post in corner of Latimer lot; thence with line of last mentioned lot, N. 31 deg. E. sixty ft. to oak post in corner of Whitman lot. (total length of western line 168 ft. 6 inches) thence with line of Whitman lot S. 50 deg. 30" E. 54 ft. 3 inches to oak post in corner of Minus lot. thence with line of Minus lot. S. 24 deg. 30" N. 61 ft. to an iron pin continuing along the line of Minus lot S. 42 deg.
