KNOW ALL MEN BY THESE PRESENTS, That I, F.M. Burnett, of Greenville, S.C.

in the State aforesaid,
in consideration of the sum of
Ten (\$10.00) dollars and other valuable considerations DOLLARS,
to me in hand paid
at and before the sealing of these presents by George R. Koester, Jr.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
George R. Koester, Jr., his heirs and assigns; All that certain piece, parcel or lot of land
lying, situate and being on the East side of Brockman Ave., in Block E., Lot #42 of San Souci
Villa, and having the following metes and bounds, to-wit: Beginning at an iron pin on the
East corner of Brockman Ave. and Young Street and running thence N. 10.30 E. ninety-one (91)
feet to iron pin, joint corner of lots #42 and #43; thence S. 57.25 E. (183) one hundred
and eighty-three feet to iron pin; thence S. 13.30 W. eighty-eight (88) feet to iron pin in
Young St.; thence along the line of said Street N. 57.25 W. one hundred seventy-six (176)
feet to the beginning corner and being the same lot of land conveyed to me by the Suburban
Land Co., Feb. 5th, 1912.

Upon condition however which is part of the consideration of this deed and condition
subsequent.

1. That no house shall be built upon this lot costing less than fifteen hundred (\$1500.00) Dollars.
2. That this property nor any part thereof shall be sold or rented or otherwise disposed of to any person of African descent.
3. That no building shall be erected nearer to the Street than the building line shown on plat, said line being 25 ft. from side walk.
