

Thomas F. Parker DEED TO Alva J. Park

KNOW ALL MEN BY THESE PRESENTS, That I, Thomas F. Parker, of Greenville County

in the State aforesaid, in consideration of the sum of Three thousand, nine Hundred (\$3,900.00) DOLLARS, to me in hand paid at and before the sealing of these presents by Alva J. Park

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Alva J. Park, all that certain lot or parcel of land situate in Ward 2 of the City of Greenville, County and State aforesaid and having the following metes and bounds: Beginning at a stake in the West line of Washington Road, corner of Lot No. 11, run north 68 degrees 52 minutes East, Sixty feet, with the West line of Washington Road to a stake, thence Southwest corner of Washington Road and Ivy Street, thence north 15 degrees 0 minutes West one hundred and forty ft. with the South line of Ivy Street, to a stake in the East line of a 10 ft. alley; thence South with the East line of said alley 68 degrees 52 minutes West 59.75 ft. to a stake, corner of Lot No. 11; thence with the line of Lot No. 11, South 14 degrees 54 minutes East, one hundred and forty ft. to the beginning; being known and designated as lot No. 22, on a plat of the property of Thomas F. Parker, Dalton, Engineer, recorded in R. M. C. office of Greenville County, in Plat Book C, page 115. This deed is subject to the following restrictions, which shall apply for a period of 20 years from date thereof, to wit: That this property or any part thereof is not to be sold, rented or otherwise disposed of to persons of African descent. 2nd. No part of any building shall be nearer Washington Road than 20 ft.

In event of violation by the purchaser of either of the restrictions above made the title of this tract shall revert to the grantor, except as against lien creditors.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Alva J. Park his heirs and assigns, forever.

AND I myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Alva J. Park and his heirs and assigns, against me my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
