All that certain lot of land situate on the South side of East Earle Street in the First Ward of the City of Greenville, in the County and State aforesaid, known and designated as lot No 2, as shown on plat of Property of F. N. Miller, by R. E. Dalton, Engineer, dated April 1919, and having the following metes and bounds to wit: Beginning at an iron pin on the South side of East Earle Street sixty feet from the intersection of Robinson and Earle Streets, joint corners of lots Nos 1 and 2, and running thence along line of lot No 1 S 6-28 1/2 198.5 feet to an iron pin; thence N 84-19 1/2 58.6 feet to an iron pin corner lot No 3; thence along the line of lot No 3 N 6-05 1/2 197.4 feet to an iron pin on Earle Street; thence with Earle Street S 85-38 1/2 60 feet to the point of beginning.
