KNOW ALL MEN BY THESE PRESENTS, That J. M. Wood + H. W. Chiles, Executors and Nannie J. Smith, Executrix of J. H. Smith, Estate,

in the State aforesaid, in consideration of the sum of Twenty-six Hundred DOLLARS, to us in hand paid at and before the sealing of these presents by W. E. and Mattie S. James,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said W. E. and Mattie S. James

All of that certain piece, parcel or lot of land situate, lying and being in the Town of Green, State and County aforesaid, and having the following metes and bounds, to wit: Beginning at the intersection of Green St; (now called Line Ave.) with Hill Street and run thence S. 2 1/4 N. 205 feet to iron spike on West side of Green St. thence N. 88 N. 103 feet with right of way of Southern Railway Company to iron spike, thence N. 4 E. 254 feet to stake on Hill Street; thence S. 62 1/2 E. 103 feet to the beginning corner and containing 5 3/100 of an acre, this being the same lot as conveyed to B. R. Zimmerman by B. F. Zimmerman by deed dated Feb., 26, 1910 and recorded in Office of Register of Mesne Conveyance of Greenville County, in Vol. 5, page 760, and conveyed by B. R. Zimmerman to J. H. Smith by deed dated March 1, 1911; with the exception of the following conveyed by J. H. Smith to E. S. Dobson by deed dated July 23, 1914, - Beginning at stake on Hill St. thence with said street S. 62 1/2 E. 11 feet to stake. thence south west course to stake on old line 91.7 feet, thence N. 4 E. with said old line to the beginning corner and containing 495 square feet, more or less.

heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
