meas, one-half interest in and to, all those certain pieces, parcels and lots situated lying and being in the County and State aforesaid, in Chick Springs Township, about five miles East of Greenville City and being known and designated as Lot No. 47, the plat of Wharton property, recorded in R.M.C. Office for said County in plat book E at page 50 and being one of the lots conveyed to me by E.M. Wharton by deed dated Sept. 10th 1917, and recorded in R.M.C. office for said County in Deed Book Vol. 52, at page 52

Also all that other certain piece, parcel and lot of land situated, lying and being adjoining the above described area being known and designated as lot # 48, having the following measurements, to wit: Beginning at a stake in the corner of lots Nos. 47 and 48, eighty feet from the National Highway and running thence N. 29.44 W. Sixty feet to a stake in lands of said E.M. Wharton; S. 60.16 E. Twenty eight feet to a stake in lands of said E.M. Wharton; S. 29.44 E.
