(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Lora E. Jenkins her heirs and assigns forever,

One half interest in all that certain piece, parcel or tract of land, situate in the County and State aforesaid on branch waters of Hilder Creek, waters of Enoree River, bounded by lands formerly of R. H. Bramlett, Butler League and others and having the following meter and bounds to wit: Beginning at rock 340 N and running thence S. 72 1/4 W. 11 chs. to a rock 340 N; thence S. 40 W. 15.38 chs. to a rock 340 W, thence S. 67 1/4 E. about ten chains to a Sower Wood 340 W thence S. 67 1/4 E. 17.40 chs. to a stake 340 W thence N. 35 1/2 E. ten chains to chestnut 37 gone, stake 34; thence N. 9 W. 22.16 chs. to rock 340 W, thence S. 41 1/2 W. 15 chains to beginning corner containing Fifty (50) acres more or less and being all the land heretofore conveyed by M.
