(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *Lorena Huff, and P. L. Bradley, all of our several interest in all that certain piece, parcel or tract of land situate lying and being in the State and County aforesaid containing (66 2/3) sixty six and two thirds acres, be the same more or less bounded by lands of W. S. Turner Thomas Bridges, and tract #4, being tract #5, of a certain parcel or tract of land, -deeded to W. A. Bradley, deceased by Josephus Bradley, A. Bradley, and others bearing date of April 18th. 1884, and recorded in P. M. C. Office of Greenville County in Book U. L. page 665, being tract #5, surveyed by W. A. Hester, Sept. 2nd. 1909.*

Bradley, their* heirs and assigns, against *ourselves* and *ours* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
