KNOW ALL MEN BY THESE PRESENTS, That *A. E. Payne*

in the State aforesaid,

to *Ella D. Barr* in hand paid  
at and before the sealing of these presents by *A. E. Payne*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *Ella D. Barr*

all those lots certain late, pieces or parcels of land, situate, lying and being in the State of South Carolina, in the County and Township of Greenville, about two miles west of Greenville Court House, known and designated as lots numbered forty-four (44) and forty-five (45) on a plat of the suburban subdivision of lands Donaldson's said plat being recorded in the office of C. R. C. for Greenville County, South Carolina, in plat book A, page 463, said two lots of land adjoining each other, and being, in the aggregate, the following metes and bounds, according to said plat, to wit: Beginning at a stake on south side of Landol Street, on joint corner of lots 43 and 44, being one hundred feet eastward from Honour's line, and running thence with Landol Street N. 74. 26 E. One hundred (100) feet to the joint corner of lots 45 and 46; thence along such joint line of lots 45 and 46 S. 15. 26 E. One hundred and forty-five (145) feet to the joint corner of lots 45 and 37; thence S. 74. 26 W. One hundred (100) feet along line of lots 38 and 39 to a stake on the joint corner of lots 40 and 44; thence N. 15. 26 W. One hundred and forty-five (145) feet along joint line of lots 45 and 44 to the beginning corner, being the said two lots of land conveyed to me by George Brownlee, by deed dated October 27th, 1913, and recorded in R. M. C. file for Greenville County, S. C. in Vol. 23 page 31.

For value received, the lien of the mortgage on the within described land executed the 22nd, day of August 1914 by A. E. Payne to A. H. Miller, and recorded in Vol. 42, page 17 to secure a debt for \$437.80, is hereby released and forever relinquished unto Ella D. Barr, her heirs and assigns.
