DEED TO Mrs. Etca A. Shalke

to me In hand paid  
at and before the sealing of these presents by Mrs. Etca A. Shalke

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Etca A. Shalke here seize and assigne, all that certain tract of land situate in the County of Greenville, State aforesaid, near the City of Greenville and having the following lines, of courses and distances, and containing Fourteen and 15/100 (14-15/100) acres more or less, Beginning at a corner piece of Grounded Hill Road (Public Road) corner lands N. 36-52 S. 394.5 to a stone on the neighborhood road; thence with line of St. M. Drive property (now McLean) property S. 36-55 E. approximately 460 feet to Center of street thence with the boundary of said property, approximately 325 feet to a stake in the northeast corner, and again turning to stake in the fence N. 1-52 S. 218 feet to stone; thence with line N. 36-55-23 E. 410 feet to stone; thence S. 36-37 E. with Ottawa line 326 feet to Driv Pipe; thence continuing with Ottawa line N. 49-36 E. 290.7 to stake; thence with line of Hammond property N. 36-22 S. 718.7 feet to a stone pipe in Grounded Hill Road (Public Road); thence with said Grounded Hill Road to the right; S. 58-13 S. 190.7 feet; S. 84-13 S. 450 feet; N. 82-53 S. 250 feet; S. 55-13 S. 100 feet, and N. 86-05 S. 100 feet across Richland Creek to the beginning corner. It is agreed and understood that said tract, Etca A. Shalke as part of the purchase price consideration assumes part of the purchase price and mortgage for which this above described land is pledged to H. M. McLean for the sum of Two Thousand and Interest from January 1st, 1918, at rate of per annum, said mortgage being recorded in office of Register of Deeds Greenville County in State aforesaid.
