KNOW ALL MEN BY THESE PRESENTS, That I, Mrs. Carrie A. Allen,
in the State aforesaid,
in consideration of the sum of
One hundred & one dollars & sixty cents (\$101.60) DOLLARS,
to me in hand paid
at and before the sealing of these presents by James E. Richey, in the State aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said James E. Richey his heirs and assigns, All that certain piece, parcel or tract of land containing Two and fifty-four hundredths acres (2.54) situate, lying and being in Grove Township, State and County aforesaid, on waters of Grove Creek, waters of Saluda River and having the following metes and bounds: Beginning at a cedar stake corner, thence S. 40-1/4 E. 6.07 to cedar stake corner on public road; thence S. 75-3/4 W. 5.34 down said road to cedar stake; thence S. 81 W. 2.01 on said road to cedar stake; thence S. 66-1/2 W. 2.43 on said road to cedar stake; thence N. 37-1/4 E. 9.00 to beginning corner. Bounded by lands of myself, C.W. Mitchell and James E. Richey.
