KNOW ALL MEN BY THESE PRESENTS, That R. H. Lee, of the County of Greenville

in the State aforesaid,

in consideration of the sum of

Two Dollars and Other Valuable Considerations DOLLARS,

to me in hand paid

at and before the sealing of these presents by Charles F. Hard,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Charles F. Hard, All that lot of land in Ward Six, City of Greenville, County and State aforesaid on South side of Elkins Street, having the following metes and bounds:

Beginning on Elkins Street at iron pipe, corner B. Wood's line and running thence South 80-14 East sixty (60) feet to iron pipe, corner Harris property; thence South 0-32 East one hundred eighty-two and 5/10 (182.5) feet to iron pipe, corner Whitmire property; thence South 89-47 West fifty-nine (59) feet to iron pipe, corner B. Wood's line; thence North 0-32 West one hundred ninety-two and 8/10 (192.8) feet to iron pipe on Elkins Street, the beginning corner and bounded on the North by Elkins Street; on East by Harris property; on South by Whitmire property, and on West by lot of land belonging to B. Wood, a plat of said land being recorded in R.M.C. Office said Greenville County in Plat Book C., page 72; being same lot conveyed to me by B.E. Geer, deed dated November 19th, 1914, recorded in said R.M.C. Office in Deed Book 26, page 407.

Hard, as a part of the consideration for this deed, does hereby agree to assume and pay my note and mortgage to Furman University of Two thousand dollars, recorded in Vol. 43, page 163, the amount due to date on said obligation being \$2418.44; also my note and mortgage to B.E. Geer of Five hundred thirty-five dollars, recorded in Vol. 43, page 164, the amount due to date on said obligation being \$81.56, both of said mortgages being recorded in said R.M.C. Office.
