the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release
unto the said Home Fund Life Insurance Company, a corporation of the State of South Carolina

situated lying and being in the City of Greenville, in Greenville Township, Greenville
County, State of South Carolina, on the North side of Pinckney Street, and having the

day of Jan'y. 1913, in Book No. 24 of Deeds, at page 127".

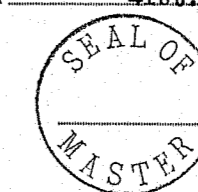
TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident
