day of March 1918, and such proceedings were had therein as resulted in a dece

for the sum of Thirty-five Hundred-twenty-five Dollars,
being at that price the highest bidder therefor.

NOW, Therefore, Know all Men by these Presents, that E. Inman
Master in and for the County of Greenville, aforesaid, in consideration of the sum of Thirty-five Hundred
Twenty-five and 25/100 Dollars,
to me paid by the said W. P. Vaughan

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release
unto the said W. P. Vaughan all that piece parcel or

tract of land lying and being in Butler Township,
Greenville County, South Carolina, known as the
home place of the late Elisha H. Hammond,
adjoining lands of Mr. F. Burgess, Walter Holcombe,
John Ellis and others, and containing twenty acre
by estimation, and being more fully described by
whites and bounds, courses and distances as will
appear from a plat made by W. A. Adams, Surveyor,
on the 15th day of March, 1918, said plat being on
file in the above entitled case. The description
of said land by meters and bounds, and courses
and distances, according to said plat, is as
follows: Beginning at an iron pin in the Lower
Hill road, Dan Elliston's line, and running
thence 45 1/2 East 165 to point in said road; thence
south 80 1/2 East 2.20 to a point in said road;

pin at the beginning corner, and containing,
according to said plat, seventeen and 5/10 (17.5)
acres.
