unto the said W. P. Longers and T. C. Rowe

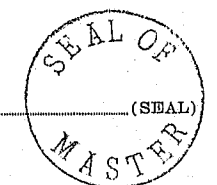
All that certain piece, parcel or tract of land, situate
lying and being in the County and State aforesaid, on the
North side of the Anderson road, at Dunham Bridge, about
ten (10) acres, more or less, and having the following
metes and bounds as shown on plat of said land by
J. N. Southern, Surveyor, dated August 18th - 1914 to wit:
Beginning at a water oak 3k on the East side of Dunham
bridge; thence with the line of the old Anderson road,
2.00 chains to a bend; thence with said road 5.00 chains
to a bend; thence 3.15 chains to bend; thence 3.20
chains to a bend; thence 4.00 chains to a bend; thence
1.25 chains to an iron pin in middle of the road,
Rollingsworth's corner; thence North 14 1/4 W. 8.00 chains
to an iron pin 3k. N. M. in middle of new road toward
the river, 8.00 chains to bend in said road, thence
still with said road 1.97 chains to middle of
ridge over branch, thence down the branch 3.00
chains to an iron pin on the bank of Saluda river
to the beginning corner, being the same tract of
