 all that piece, parcel or lot of land in *Greenville* Township, Greenville County, State of South Carolina.

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina and County of Greenville, near the City of Greenville, on the Spartanburg Road and having the following lines, metes and bounds, to-wit: Beginning at a pipe in the edge of the Spartanburg Road and running thence with Watkins' line N. 30-27 W. 312 feet to a pin Watkins' corner; thence with the rear line of said Watkins' N. 31-38 E. 25 feet to Watkins' corner; thence N. 40-27 W. 84 feet and 3 inches running across a small branch to a pipe corner just beyond branch; thence S. 22-30 W. 81.8 feet to a pipe corner on line, being the rear line of Watkins' line projected (said rear line being S. 31-38 W.); thence S. 24-45 E. 323 feet to a pipe on edge of the Spartanburg Road; thence with the edge of said Road N. 69-32 E. 70 feet to the beginning corner.
