

Eagle Park Company DEED TO *J. W. Jersey*

KNOW ALL MEN BY THESE PRESENTS, That *Eagle Park Company*

a corporation chartered under the laws of the State of *South Carolina*, and having its principal place of business at *Greenville*, in the State of *South Carolina*, for and in consideration of the sum of *Fifty-five Thousand Dollars (\$55,000.00)* DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto *J. W. Jersey*

all those certain lots or parcels of land, situate, lying and being in the City of Greenville on the south side of Tindal Avenue, being known and designated as lot 24 and 25, and part of lot 36 of Block B, and having the following corner and bounds, to wit: Beginning at an iron pin on the south side of Tindal Avenue, back running thence with Tindal Avenue, N. 89.07 E. 155.4 ft. to an iron pin, thence S. 51.10 W. 2.65 ft. to an iron pin, corner of lots 22 and 24, thence N. 47.44 W. 184.6 ft. to an iron pin. Corner of lots 19 and 20, thence approximately N. 0.23 E. 2.22 ft. more or less to the point of beginning on Tindal Avenue, as shown on plat of Eagle Park recorded R.M.C. office for Greenville County Plat Book C, page 238.

Subject, however, to the following restrictions which are part of the consideration for this deed, also are made for the benefit and protection of the other lots shown on the plat above referred to which restrictions shall remain effective for a period of twenty years from the date of this deed, to-wit: 1. The property herein conveyed nor any part thereof shall not be sold, rented or otherwise disposed of to Negroes. 2. The said property shall not be used for any unlawful business nor for anything which would constitute a nuisance. 3. The property herein conveyed shall not be resold nor subdivided so as to face any other direction than as shown on said plat. 4. No building shall be erected upon said property within 25 feet of the present line of Tindal Avenue. 5. No building costing less than \$1500.00 shall be erected upon said lot other than out buildings appurtenant to a dwelling.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... hereinabove named, and *his* heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and *his* heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
