Ten (\$10.00) Dollars and other valuable considerations DOLLARS,

to me in hand paid

at and before the sealing of these presents by William J. Burty

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said William J. Burty, his heirs and assigns, forever. All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County and State aforesaid, and being known and designated as lot 27 on a plat of lands known as Townes Street property, said plat made by Wm. D. Neves, C.E. October 1909, and recorded in the R.M.C. Office for Greenville County, S.C. in plat book of Cleveland & Williams, and having according to said plat the following metes and bounds, to-wit:- Beginning at an iron pin on the East side of Wilton Street, joint corners of lots 27 and 28 and running thence along line of lot No. 28, S. 76 E. 186 feet to an iron pin on a 14 foot alley; thence along line of said alley N. 14 E. 60 feet to an iron pin corner of lots 27 and 26; thence along line of lot No. 26 N. 76 W. 186 feet to an iron pin on Wilton Street; thence along Wilton Street S. 14 W. 60 feet to beginning corner, and being part of the land conveyed to me by W.C. Cleveland by deed dated February 23, 1912, and recorded in R.M.C. Office for Greenville County in Vol. 12, page 291.
