 in consideration of the sum of *any equal portion and division of the Estate of Emma E. Bramlett*  
 to *us* the further consideration of the sum of five (\$5) Dollars in hand paid  
 at and before the sealing of these presents by *W. H. Bramlett*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, sell and Release unto the said *W. H. Bramlett*, all that piece parcel or tract of land situate lying in the State and County aforesaid on the head waters of *Winn Creek*, waters of *North Saluda River* and in *Saluda Township*, and has the following metes and bounds to wit:  
 Beginning at a stone corner of *Mary Pool*; thence N. 14 E. 18.70 chains to a stone; thence S. 86 W. 21.00 chs to a stone; thence S. 44 E. 23.90 chs. to the beginning corner, containing nineteen (19) acres, more or less.
