(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said
Mrs. Mabel M. B. Charles, her heirs and assigns,
All that certain piece parcel or tract of land situate,
lying and being in the State of South Carolina,
County of Greenville, in Aggett Township, about four
miles south of Greenville Court House, on the North-
East side of the White Horse Road, and on the West
side of the Columbia & Greenville Railroad, at White
Horse Station on the Greenville, Spartanburg and
Anderson Railway, on the ridge between the waters
of Saluda River and the waters of Edy River,
and having the following metes and bounds:
Beginning at a stake on the White Horse Road,
beginning at a stake on the Salem Church lot and running
on the line of Salem Church lot and running
thence along the said line N 11° 48' E 3.40 chains
to a stone on the Northwest corner of Salem Church
lot; thence along line of said lot S 77° 48' E 8.50
chains to a stone 37.0 m. Northeast corner of Salem
Church lot; thence N 11° 48' E 4.40 chains to a stake
on the Columbia and Greenville Railroad; thence
