Eight Thousand DOLLARS,
 to me in hand paid
 at and before the sealing of these presents by A. L. Henderson

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said A. L. Henderson, All that certain piece, parcel or tract of land, situate, lying and being in the County of Greenville, and State of South Carolina, Betes Township and in the Town of Athens (Travelers-Rest), on a small branch of the head waters of Enoree River, and having the following metes and bounds, according to a plat made by J. N. Southern, D.S., bearing date Jan. 2, 1896 as follows:— Beginning at a stone 3xom, Mrs. Mary Plyler and John Love's land, and running thence with said Plyler's line S. 79-1/4 W. 15.76 to a stone 3xom; thence S. 30 E. 13.41 to a stone 3xom on the old line; thence N. 21-3/4 E. 5.50 to a stone 3xom; thence N. 47-1/2 W. 63 links to a stone 3xom; thence N. 38-1/2 E. 11.58 to the beginning corner and containing 8-8/10 acres, more or less.
