KNOW ALL MEN BY THESE PRESENTS, That I, R. L. Middle of Felzer and

in the State aforesaid, in consideration of the sum of

14 one Hundred and no/100 DOLLARS,

to me in hand paid

at and before the sealing of these presents by R. L. Jordan

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

R. L. Jordan his heirs assigns forever, all that certain piece parcel or parcel of land situate lying and being in Oaklawn Township, Greenville County State of South Carolina and having the following meters and bounds to wit: Beginning at a stone on corner of Pine Avenue and Smyth Lane, and running thence with Pine Avenue N. 86. 8. 6.53 chains to a stone; thence S. 20. 75. W. 6 chains to a stone; thence N. 69. 75. W. 5.26 chains to a stone on Smyth Lane; thence with Smyth Lane N. 20. 75. E. 3.60 chains to beginning corner, containing two and fifty two one hundredths (2 + 52/100) acres, more or less, and known as lot number twenty (20) on plat of Arden made by Jno M. Cureton D. S. Nov. 10, 1806 and being the same land conveyed to me by deeds of L. O. Craddock on June 7th, 1910, and being recorded in the office of Register of Mense Conveyance for Greenville County, South Carolina in Book 8 page 485.

Also all that other certain piece parcel or lot of land situate lying and being in Oaklawn Township, Greenville County, South Carolina and having the following meters and bounds to wit: Beginning at a stone on Smyth Lane 3.60 chains from corner of Smyth Lane and Pine Avenue and running thence with Smyth Lane S. 20. 75. W. 7.20 chains to a stone thence S. 65. 75. E. 8.85 chains to a stone; thence N. 20. 75. E. 7.20 chains to a stone thence N. 65. 75. W. 8.85 chains to the beginning corner on Smyth Lane; containing six and thirty eight one hundredths (6 and 38/100) acres, more or less, and known as lots numbers twenty one and twenty two on plat of Arden made by Jno M. Cureton, D. S. Nov. 10th 1806, and being the land conveyed to me by deeds of T. C. Cureton D. S. Nov. 10, 1806, and being the same land conveyed to me by deeds of H. D.
