KNOW ALL MEN BY THESE PRESENTS, That Mr. W. I. Henderson, T. F. Hunt  
and H. W. Hunt

in the State aforesaid,  
in consideration of the sum of  
Ten dollars and other valuable considerations DOLLARS,  
to us in hand paid  
at and before the sealing of these presents by J. F. White

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

J. F. White, his heirs and assigns.  
All that certain piece parcel or lot of land situate  
lying and being in Greenville County, State of South  
Carolina, about two miles West of Greenville Court  
House, and being a portion of a subdivision known  
as "City View"

Beginning at a stake on M<sup>c</sup>D. Ave, two hundred  
and fifty feet from the new Cut Road, corners of lots  
nos. 140 & 141 and running thence with joint lines  
of said lots in an westerly direction 150 feet to a stake  
on a ten foot alley, thence in a southerly direction on  
line of alley 75 feet to a stake; thence in an Easterly  
direction 90 feet to a stake on M<sup>c</sup>D. Ave, thence in  
a northerly direction with said M<sup>c</sup>D. Ave 75 feet  
to the beginning corner, and being designated as lots no.  
141 and that of lot no. 142, according to a plat made by  
W. A. Adams, Surveyor.

Also all of that certain lot in the same subdivi-  
sion designated as lot No. 149. Beginning at a stake on  
Hunt Street, joint corners of lots nos. 148 & 149 in run-  
ning with joint lines of said lots an an easterly  
direction 100 feet to a stake, on a ten foot alley,  
thence in a northerly direction with said alley 50  
feet to a stake, <sup>thence in a southerly direction with line of Hunt St. 50 feet</sup>  
corner lots no. 149 & 150, to a stake corner  
of lots 148 and 149, the beginning corner.
