J.J. Gantt, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the South side of Perry Avenue, and having the following lines, courses and distances, to-wit:

Beginning at a stake on the South side of Perry Avenue a distance of sixty (60) feet from the corner of Willis Street and Perry Avenue, and running thence along Perry Avenue N. 71-0 W. one hundred one and four-tenths (101.4) feet; thence S. 29-45 W. one hundred eighty-nine and five-tenths (189.5) feet; thence N. 63-49 W. twenty-six (26) feet; thence S. 18-50 W. thirty-eight (38) feet; thence S. 70-16 E. one hundred and forty-one (141) feet, and thence N. 18-44 E. two hundred and twenty-six (226) feet to the beginning corner.
