(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Daisy G. Stroud (1) All that piece, parcel or lot of land situate and being in the State and County aforesaid, in town of Marietta, on the South side of Jones Gap Road, known as part of the O.N. Good place, adjoining lands of E.C. Stroud, bounded as follows: Beginning at a stake in Jones Gap Road, E.C. Strouds' corner; thence S. 59 W. 8.19 to a stake; thence N. 34 W. 1.51 to stake; thence N. 59 E. 3.14 to a stake; thence S. 37 E. 1.51 to the beginning corner, containing $1\frac{1}{4}$ acres, more or less.

(2) Also all that other piece, parcel or lot of land lying, situate and being in the State and County aforesaid, in the town of Marietta, known as part of O.N. Good place and lot 2 adjoining lots 1 and 3, bounded as follows: Beginning at a stake in Jones Gap Road; thence with said Road N. 41 W. 1.20 to R.O.; thence S. 59 W. 3.50 to stone; thence S. 41 E. 1.20 to a stake; thence N. 59 E. 3.50 to beginning corner, containing $\frac{42}{100}$ of an acre, more or less.

(3) Also all that other piece, parcel or lot of land, situate and being in the State and County aforesaid, Marietta town, known as part of O.N.
