Beginning at an iron pin at intersection of Paris Mountain Road and Turners or American Spinning Company Road, and running in the Southeastern direction 394 feet to an iron pin; thence N. 38° 30' W. 350 feet to an iron pin; thence N. 43° 12' E. 415 feet to an iron pin; thence N. 86° 42' E. 246 feet to center of Paris Mountain Road, thence with center of Paris Mountain Road in a southerly direction 434 feet to the beginning corner, and containing five (5) acres, more or less and being the same lot of land conveyed to us by M.
