Dowling, all that certain piece of land or lot of land in Greenville County, State of South Carolina, in Ward One of the City of Greenville, and having the following metes and bounds to-wit: Beginning on a stake in the S. E. corner of Mary A. Stewart and Lillie S. Sumate lot on north side of Washington Street and running thence 20 and 2/3 E. seventy-two feet along the north side of said street to a stake in the north west corner of lot of Morgan and Austin; thence N. 40 E. One hundred sixty-five feet to a stake 34; thence N. 50 3/4 W. seventy-two feet to a stake in corner; thence S. 40 W. with Stewart and Sumate line one hundred sixty-five feet to the beginning corner and being the usual lot conveyed to me by Mable McB. Charles Nov. 6th. 1919.

heirs and assigns, against me and my heirs and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
