Dillard, all that certain <sup>five</sup> parcel or tract of land situate, lying and being in the State and County aforesaid, and having the following description: Being lots Nos. 12, 13, 20, 24 and 25 in block No. 1 and lots Nos. 12, 3, 4, 5, 6 and 7 in block No. 2 of the J. A. Barnard's property near Greenville, S.C. and known as "Barnard's Cade" according to plat of said property made by H. S.
