W.L. Campbell, and his heirs and assigns forever, the following described real estate:
"All that certain piece, parcel or tract of land situate, lying and being in Highland Township
in the County of Greenville and State of South Carolina, containing *18.8* acres, more or less,
and known and designated as Tract No. *3* as shown by a survey and plat of the estate of A.L.-
Campbell made by R.E. Dalton, Engr., in October 1921 and having the following metes and bounds
and courses and distances:
Beginning at a pin on Beaverdam Creek at corner of lands of N.B. Campbell, and running
thence S. 11.10 W. 943 feet to a stone on branch; thence S. 81.40 E. 142 feet; thence S.
80.35 E. 187 feet to a stone; thence along the line of lands of A.H. Campbell S. 2.00 W. 647
