This Indenture made this the 17th, day of September 1920 by and between Q.A. Greene, of the one part hereinafter called Lessor, and B.B. Waldrop, of the other part, hereinafter called Lessee, Witnesseth: That the Lessor has hereby let and rented to the lessee and the lessee has hereby hired and taken from the Lessor, that certain lot of land situate in the State and County aforesaid, just across the road from the Northern or second entrance to the Base Hospital grounds, Camp Sevier, and fronting the road leading by said hospital, beginning at a point on said road opposite the end of the road pavement, and running along said road toward the main or Chick Springs Road loo feet; and running back in parallel lines 150 feet, together with the store-room, two small houses and the latrine situate thereon.
