Rowley executed and delivered to his daughter Lillie May Woodside a deed hearing date May 9, 1903 and recorded in the office of the Register of Mesne Conveyances for said County and State in Deed Book "JJJ", at page 537, which deed conveyed the un-numbered lot on the northwest corner of North and McGee Streets, in the Second word of the City of Greenville, in said County and State, marked "A. L. Woodside" on the plat of the Rowley Place made by W.A. Adams, bearing date January 11, 1912, and recorded in said Office in Plat Book "C", at page 5; together with that portion of the ten foot alley lying immediately north of said lot; together with a lot measuring 40 x 75 feet lying immediately north of said alley and constituting the south-east portion of lot No. 44 on said plat;

And Whereas, T.F. Hunt, R.J. Royley and E.F.S. Hubbard to whom all of his real and personal property descended by operation of the statute of distributions of said State;

Lathrop, Mary R. deSauddure, Sara R. Wannamaker, Laura R. Jackson and Mannie R. Hubbard, in consideration of the premises and for the purpose of removing the cloud apparently resting upon the title to said land, and in further consideration of the sum of one dollar to each of us in hand paid at and before the sealing and delivery of these presents by the said billie May Woodside (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released and do hereby grant, bargain, sell and release unto the said Lillie May Woodside all of the right, title, interest, estate, claim and demand whatsoever, both at law and in equity which is now or might at any time hereafter be asserted by us or any of us, or by our or any of our heirs or assigns in or to lot No. 44 as shown on plat hereinabove referred to; said lot having according to said plat the following metes and bounds, to-wit: - Beginning at a stake on the south-east corner of said lot (which stake is on the north-west corner of McGee Street and the ten foot alley above referred to and is one hundred and ninety (190) feet from the north side of North Street), and running thence along McGee Street N. 21° 45' W. fifty and one-tenth (50.1) feet, more or less, to a stake on the south-east corner of lot No. 45; thence S. 76° 30' W. one hundred and fifty-five (155) feet along the line of lot No. 45, to a stake on another ten foot elley; thence with said last mentioned alley S. 21° 45' E. fifty-two and six tenths (52.6) feet to a stake on the corner of the two -
