This Agreement made and entered into this the 2d, day of February 1922, by and between The Peoples Trust Company, part of the first part, and J.D. Richardson of Anderson, S.C., party of the second part, Witnesseth-

In consideration of the mutual agreements hereinafter mentioned and the receipt of one dollar to each of the parties in hand paid by the other, the said J.D. Richardson hereby agrees to sell and convey to The Peoples Trust Company, its successors or assigns, an undivided one-third interest in a certain apartment house located in Greenville, S.C., and on Washington Street therein, known as the Cunningham Apartment House, at and for the sum of Twenty-three thousand (\$23,000.00) Dollars, The Peoples Trust Company to assume the payment of a ten thousand (10,000.00) dollar mortgage on said undivided one-third interest in said premises as part of the purchase price; also a certain apartment house in Greenville, S.C., on Pendleton Street, and known as the Strawn property, at and for the sum of Fifty thousand (\$50,000.00) dollars, The Peoples Trust Company to assume a mortgage for twenty-five thousand (\$25,000.00) dollars on said property as a part of the purchase price; and also to sell and convey or cause to be conveyed to said Peoples Trust Company, a three story store building two stores wide in the City of Creenwood on Main Street and known as the C.C. and J.P. Wharton property, at and for the sum of seventy-five thousand (\$75,000.00) dollars, The Peoples Trust Company assume the mortgage of thirty-eight thousand (學好,000.00) Dollars on said property as a part of the purchase price.
