McGhee, of the City of Greenwood, in the County and State aforesaid, in consideration of the premises and of the sum of Ten Dollars to me in hand paid at and before the sealing and delivery of these presents by G.Allen Barks, of the County and State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G.Allen Banks, his heirs and assigns forever:

lst. All and singular that tract or piece of land situate, lying and being in the County of Greenwood, State of South Carolina, containing One hundred and sixty (160) acres, more or less, and bounded by lands formerly of Dennis Washington, lands of Mary McGhee, and lands of Ben Franklin and R.R. Tolbert, said lands having been conveyed to me by H.W. Butler, Nov. 30, 1917, and on which there is no lien or mortgage.

2nd. All and singular that certain tract or parcel of land in the County of Greenwood, State of South Carolina, containing one hundred and thirty three (133) acres, more or less, and bounded by lands of Mary McGhee, R.R. Tolbert, S.H. McGhee and others, and by Public Road, the same being the Dennis Washington lands and on which there is no lien or mortgage.

3rd. All my undivided interest in that certain tract or parcel of land in the County of Greenwood, State of South Carolina, containing One hundred and ninety-seven (197) acres, more or less, and bounded by lands formerly of Mrs.Lila O.
