(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Virginia Manufacturing Company

all the lands belonging to said Natine Manufacturing Company situated in the County and State aforesaid upon the waters of Reedy River and containing approximately, sixty nine and seventy one hundredths (69.70) acres or more or less, together with all riparian rights granted to said Corporation or reserved by said Corporation in conveyances made by it and all other rights and privileges connected with the operation of its power plant on Reedy River. Together with the buildings, machinery, and appliances constituting a part of its power plant and with all power lines, telephone lines, and all rights of way connected therewith. Also all supplies used in connection with said power plant. This deed is made in pursuance of and in conformity with the powers vested in us by Natine Manufacturing Company as aforesaid. The intention being to also hereby convey all property, including mill buildings, warehouse, tenements, lands and just

Virginia Manufacturing Company, its Successors heirs and assigns, against us ourselves as trustees and heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
