I, E. Inman, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Florence A. Shockley, as Administratrix of the estate of J. H. Shockley, and in her own right, et al.

on or about the 16th day of November in the year of our Lord nineteen hundred and twenty-one exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against Phelma Shockley, et al,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 19th day of December 1921, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman

Master in and for the County aforesaid, to C. S. Hammett for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No.)

NOW, Therefore, Know all Men by these Presents, that I, E. Inman, Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$893.55 HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

C. S. Hammett and his heirs and assigns forever, the following described real estate: All that certain piece, parcel or lot of land situated in Chick Springs Township, County of Greenville and State of South Carolina, and in the Town of Taylors, and being known and designated as Lot No. 34 or a subdivision of Lot No. 2, property of W. M. Shockley, Deceased as shown by subdivision and Plat of same made by Geo. J. Linder, Nov. 10, 1921, and recorded in the R. M. C. Office for the County and State aforesaid, in Plat Book "F" at page 20. This Lot contains 8.51 acres and is more particular described as follows: Beginning at iron pin across the Public Road and in line of W. Alewine and runs thence N. 86 W. 13.34 to corner of Lot No. 29; thence along the rear lines of Lots 29, 30 and 31 6.32 to point in line of Lot No. 32; thence along line of last mentioned line S. 36 E. 13.60; thence N. 1 W. 6.32 to the beginning corner. Reference is hereby craved to the plat above referred to for a more particular description of said Lot.
