HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said \_\_\_\_\_

Ernest Thompson and his heirs and assigns forever, the following described real estate:  
"All that certain piece, parcel or lot of land situated in Chick Springs Township,  
County of Greenville, and State of South Carolina, and in the Town of Taylors, and being  
known and designated as Lot No. 27 on a Subdivision of Lot No. 2, property of W.M.-  
Shockley, Deceased, as shown by subdivision and plat of same made by Thos. T. Linder Nov.  
10, 1921, and recorded in the R.M.C. Office for the County and State aforesaid in Plat  
Book F, at page 20. This lot contains 4.55 acres and is more particular described as  
follows:  
Beginning at the South east corner of Lot 26 and runs thence N. 60-1/2 E. 5.45 along the  
line of Lot No. 26 to stake; thence S. 1-1/2 W. 9.39 to corner of lot No. 28; thence along  
the line of lot No. 28, S. 88 E. 5.82 to point in line of lot No. 32; thence N. 1-1/2 E.
