(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

E. L. Chiles, his heirs and assigns forever:-

Lot no. 1. All that certain piece, parcel and lot of land situate lying and being in the County + State aforesaid, and in Ward 1 of the City of Greenville, and on the Southeast side of Echols Street and between Hampton Avenue (formerly West St.) + John St. + being described as follows: Beginning at a stake on Hampton Avenue, Corner of John Blyndine lot, and running thence along the South side of Hampton Avenue N. 42 1/2 W. 3 chs. + 5 links to a stake at corner of Hampton Avenue + Echols St. thence S. 55 3/4 W. 7 chs. + 7 links to a stake at corner of Echols + John Sts. thence along John St. S. 5 1/2 W. 7 chs. + 93 links to a stake at corner of Reeves lot thence N. 33 1/2 E. 6 chs. + 59 links to the beginning corner land containing 3 2/3 acres more or less, except however, from the lot herein described those two certain lots heretofore conveyed by the said J. A. S. Barr to W. A. Hudson, W. S. Agnew and P. E. Smith, Trustees of the Third Presbyterian Church by his deed dated Nov. 25, 1899, which deed is recorded in the P. M. C.
