Office for Greenville County in Plat Book C., at page 10, said lot being 253.8 feet from Rutherford Road, and beginning at the corner of lot #3 on Mountain View Avenue and running thence N. 25 E. 164.5 feet to an alley; thence S. 65 E. with said alley 100 feet to corner of lot #5; thence with line of lot #5, S. 25 W. 164.5 feet to Mountain View Avenue; thence N. 65 W. with Mountain View Avenue 100 feet to the beginning corner, being the same lot of land conveyed to me, the said Frances Pickett Mellichamp, by G.A.
