in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said R.F. Watson, his heirs and assigns forever

all that piece, parcel or lot of land in Ward Five, Greenville Township, Greenville County, State of South Carolina.

on the south side of Birnie Street, and having the following metes and bounds, and dimensions, to-wit: Beginning at the northeast corner of the lot sold to D.E. Lineberger, by Thos. Q. Donaldson, on the day of July, 1904 and recorded on October 2nd, 1905 in Volume 000, page 595, R.M.C. Office for Greenville County, and said State; and running thence with same line of the Lineberger lot, and parallel with the Western line of said Lineberger lot, S. 28 $\frac{1}{2}$ W. 217 $\frac{1}{2}$ feet to a point in the line of E.B.
