Lot No. 1, Block "E": Beginning at an iron pin on the corner of Mauldin and Meadow streets, and running thence with Meadow street, N. 2-45 W. 24.4 feet to corner of lot No. 5, thence with line of lot No. 5 N. 87-15 E. 10 feet to corner of lot No. 3, thence with line of lot No. 3 S. 2-45 E. 1 foot to Mauldin street, thence with Mauldin street S. 6-45 W. 20.5 feet to the beginning corner.
