in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *Ella W. Hard, her heirs and assigns, forever*

all that piece, parcel or lot of land in *Greenville* *City of Greenville and* Township, Greenville County, State of South Carolina.

situate on the Southwest side of *McBee Boulevard*, just outside the city limits of *Greenville*, and described as follows:— Beginning at the corner of Lot No. 3 and runs thence N. 39-50 W. 24 feet and 11 inches; thence S. 50-10 W. 178 feet and 10 inches; thence S. 39-55 E. 24 feet and 11 inches to corner of Lot No. 3; thence along the line of that lot N. 50-10 E. 178 feet and 10 inches to the beginning corner, being the southern part of Lot No. 5 of Block H, as shown by plat recorded in Plat Book "A", Page 122, and being the same lot of land conveyed to me by Margaret Scott Moffett by deed dated October 4th, 1919 and recorded in Volume 56, page 178, R.M.C. Office for Greenville County, South Carolina.

Also: All that other piece, parcel or lot of land near the City of Greenville, County and State aforesaid, known as Lot No. 3, Block "H" on plat of lands belonging to the Furman Investment Company, and said lot was transferred to said *Johanna Bornemeyer*, April 29th, 1918, deed recorded in Volume 25, page 396, R.M.C. Said lot has the following metes and bounds, to-wit:— Beginning at a point on the West side of *McBee Boulevard*, joint corners of Lots Nos. 1 and 3; thence with said Street N. 39-50 W. 49 feet and 11 inches to corner of lot No. 5; thence along line of lot No. 5, S. 50-10 W. 178 feet and 10 inches to point joint corner of lots Nos. 4 and 5; thence along line of Lot No. 2, S. 39-55 E. 50 feet; thence along line of lot No. 1, N. 50-10 E. 178 feet and 9 inches to the beginning corner.

heirs and assigns, against *myself* and *my* heirs, and every other

person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
