The above right-of-way is for a pole line running from Franklin Process Company plant along Beacon Ave. thence in a straight line across Mills Mill land and Duncan Mills pasture to a point intersecting and tapping the Duncan Mill line. Said line to be of poles and subject to relocation in case it conflicts with future developments of Mills Mill and not to conform to any streets which they may lay out. The Power Company will at its own expense relocate same.
