(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Slattery & Henry, a Corporation
All that certain lot or parcel of land situated, lying and being just without the corporate limits of the City of Greenville, near West Washington Street on an alley, bounded by the property of Carey, Mason and Marchant, and having the following metes and bounds, according to a plat of *P. G. Dalton, Engineer of Record* in Plat Book 16 at page 2024, to wit:

Beginning at an iron pin on an alley, corner of property of myself, Marchant, Carey and Mason, and running thence with their line (North 30.12 W. 9) feet to an iron pipe, thence still with their line N. 62.34 E. 57.6 feet to an iron pipe, thence with their line S. 46.03 E. 16.1 feet to an iron pipe, thence still with their line S. 30.12 E. 67.4 feet to an iron pipe on a 15 foot alley, thence with said alley S. 52.45 W. 64.6 feet to the point of beginning, together with all my right, title and interest in, and to all alleys and streets shown on the plat above mentioned.

This is the identical lot conveyed to me by a person named Rogers in 1885, the deed to which was lost without ever being put on record, and I represent that I have been in peaceable possession of and collecting the rents from the said property since the year 1885, and I further represent that this is all the property I own of the lands shown on the said plat.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

I HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *Slattery & Henry, a Corporation, its successors* heirs and assigns, forever.

AND *I* myself, *my* do hereby bind heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

Slattery & Henry, a Corporation, its successors heirs and assigns, against *me* and *my* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
