KNOW ALL MEN BY THESE PRESENTS, That Victor-Managhan Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, in the State of South Carolina for and in consideration of the sum of Dollars and other Valuable Considerations,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Piedmont Bonded

Warehouse and Express Company; All that certain piece of land situate, lying and being near' the Northwestern corporate limits of the City of Greenville, in Greenville Township, State of South Carolina; and being more particularly described according to a plat thereof prepared by B. G. Dalton, Engineer, in August 1924, as follows, to-wit:

Beginning at a stake on the Northeastern side of Washington Road at or near the Eastern bank of the old run of Reedy River and running thence with Washington Road $4^{\circ} 42' - 34^{\circ} E$ 89 feet to a monument, thence $77^{\circ} 30' - 51^{\circ} 9.5'$ feet to a monument in the Western line of the right-of-way of the Piedmont & Northern Railway, thence with said right-of-way $77^{\circ} 31' - 10^{\circ} E$ 48.5 feet to an iron pin in the center of a Southern Railway siding, thence with the center of said track $0^{\circ} 00' - 34^{\circ} W$. 300 feet to a stake; thence still with the center of said siding $0^{\circ} 20' - 00^{\circ} N$. 100 feet to a stake; thence still with the center of said siding $0^{\circ} 56' - 58^{\circ} W$. 100 feet to a stake; thence still with the center of said siding $0^{\circ} 56' - 38^{\circ} W$. 100 feet to a stake; thence still with the center of said siding $0^{\circ} 56' - 25^{\circ} W$. 100 feet to a stake; thence still with the center of said siding $0^{\circ} 56' - 18^{\circ} W$. 78.2 feet to a stake in the center of the old run of Reedy River, thence $4^{\circ} 14' - 31^{\circ} E$ 162 feet to the beginning corner and containing according to said plat fifty-five hundredths ($55/100$) of an acre.

This conveyance is made subject to the rights of the Southern Railway Company in and to and along said side track.
