has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Mary G. Traxler, her
heirs and assigns forever: All those certain pieces, parcels, tracts or lots of land
situate, lying and being in the County and State aforesaid, more particularly described as
follows, to-wit:

Lot No. 197:

Beginning at the southeast corner of the intersection of Mount Vista Avenue and an unnamed
street or avenue, and running thence in a southwest direction 83 feet and 7 inches along
said Mount Vista Avenue to joint corner of lots Nos. 196 and 197; thence in a southeast
direction 190 feet along the eastern line of lot No. 196 to joint corner of lots Nos. 196,
197, 201 and 202; thence in a northeast direction along rear lines of lots Nos. 199, 200
and 201 to a point on said unnamed street or avenue; thence with last mentioned street or

Tract No. 1:
