D. Workman, his heirs and assigns forever: All those certain pieces, parcels or lots of land, in the city of Greenville, County in state aforesaid, being more specifically described as follows:

1. Lots nos. 10, 11, 12, 17, 18 and 19 according to plat of property known as property of Rush Bros. recorded in the R. M. C. office for Greenville County in plat book "D" page 184 reference being made to said plat for a more complete description.
2. Lots nos. 40 and 41 as shown on plat of property recorded in the R. M. C. office for Greenville County in plat book E page 146. Reference being made to said plat for a more complete description.

3. Lot at the southeast corner of Hampton and Davis Street, city of Greenville: Beginning at a stave on the east side of Hampton Avenue and the south side of Davis Street, at the corner of said streets, running thence S. 32° 40' E. with Abbepton Avenue 45 feet to a stave, thence N. 57° E. 100 feet to a stave, thence N. 32° 40' W. 45 feet in a line parallel with Hampton Avenue to a stave on Davis Street, thence with said Davis Street, S. 57° W. 100 feet to point of beginning.

4. Lot herein as "Garage", on the E. side of West Coffee Street, Beginning at a point on said street which is the corner of the Crosskey property at a railroad spike, running thence S. 21° 00' W. 104.2 feet to an iron pin, thence S. 67.5° E. 33.2 feet along the property of the Presbyterian Church to a fence post, thence S. 21.2° E. 105 feet to an iron pin on Coffee Street, at a point 117 feet from Richardson St. thence along said Coffee Street N. 69.21 W. 33.8 feet to the point of beginning.
